President's Address -A. Melo

Dear CIFFA Members,

Today, as we launch into our Annual General Meeting, I want to thank you for your presence and involvement here today.

I also want to acknowledge the incredible honour of serving you in the role of President of CIFFA. Every year brings new challenges and opportunities to our industry and this year has been no different.

Increasingly we've observed the transformation of hot spots into global events that directly affect us. Examples include unrest in the South China Sea, the Red Sea crisis, war in parts of the Middle East and Europe. Climate change and natural disasters like volcanoes, floods, drought, and extreme heat and cold directly impact how we do business. Impromptu and unpredictable remarks by world leaders cause repercussions at a speed that have many of us spinning as we try to adjust and create stability in a new normal.

CIFFA continues its steady leadership as we pass our 75th year and head into the future of logistics. We could not do anything without our members. Thank you for your support of our Association. As always, we welcome you and the valuable input and contribution that you provide to strengthen our industry.

To our longstanding members, we wish to thank you for your continued loyalty, and for those who have joined us recently, thank you for helping us continue our work as the trusted advisor to our industry since 1948.

As you may already know, CIFFA extended its regular membership categories to encompass drayage operators, 3PL load brokers, warehouse operators and Customs Brokers. All of these sectors are an integral part of the supply chain and collectively this will strengthen our voice and provide a broader reach.

March 26th of this year marked a momentous day in our Association's history. In recognition of the additional sectors added, a Special Meeting of Members was held to vote and approve a name change. It is with great honor and privilege that I announce to you that we will now be officially known as CIFFA, incorporating the name CIFFA Corp. This new name will be accompanied with a new tagline, Forging Alliances. Truly representing the right voice, conditions and positioning to ensure long-term success for our members.

CIFFA's path and focus have not changed throughout the decades, prioritizing the three important pillars of Membership, Advocacy and Education to drive our success. This foundation will remain intact as we forge ahead.

When people deal with CIFFA member's, they know they're working with trained professionals

who carry Cargo Liability Insurance and who abide by the FMSCA Surety bond requirement.

Established organizations and businesses trust that reputation.

Membership with CIFFA also helps protect your business. <u>CIFFA's newly updated Standard Trading Conditions (STCs)</u> and General Agency agreements can only be used by a CIFFA member. These conditions, which govern the relationship between CIFFA regular member firms and their clients, are regularly upheld in Canadian courts.

Members can also benefit from special pricing on all events, education, training initiatives and obtain further savings through CIFFA's Affinity Program. The CIFFA Affinity program is designed exclusively for the benefit of our members. The goal is to add value for all member firms and their employees through special offerings.

We hope to continue the strong tradition of delivering quality events to our members just like the magnificent conference we attended this week.

As we have noted, there has been a lot of uncertainty and volatility in the world economy and in global markets affecting the supply chain.

For this reason, our work on the Advocacy front has become paramount to the success of the association and to facilitating how CIFFA members do business.

We are involved in various committees, both domestic and international, representing CIFFA on matters like air cargo, marine, rail, trucking, drayage, customs, regulatory, sustainability and technology.

We maintain excellent relationships with supply chain partners and with our sister associations. We always look for opportunities to combine efforts and to share our respective strengths. We are the trusted advisors to our members, international partners and government legislators.

CIFFA's approach is to be proactive, not reactive, and it has long been our position that we must work collaboratively on common solutions if we are to enable real change.

Together with our lobbyist, we are trying to break down the siloes, and bring all stakeholders to the table, to collaborate on supply chain issues for positive action and outcomes.

To that end, we are very proud of our considerable achievements over the course of last year and this year:

- CIFFA is regularly consulted by the recently launched Supply Chain Office on issues affecting supply chain.
- We held regularly scheduled meetings with rail, freight forwarder, drayage and customs partners on congestion and clearance issues for containers at the ports and rail terminals.
- We have pushed back on unfair application of detention and demurrage charges through the Competition Bureau, Transport Canada and via our legal counsel.
- We have participated as witnesses on the federal Standing Committee on Transport, Infrastructure and Communities.
- CIFFA is regularly invited to provide comment on changes to the Transportation of Dangerous Goods Act, The Customs Act, Transportation Security Clearances and the Canada Transportation Act and associated regulations.
- CIFFA is also supportive of the repeal of the Canada Shipping Conferences Exemption Act. The Government recently undertook a review of the Competition

Act where the CIFFA raised this issue. CIFFA submits that repealing the Shipping Conference Exemption Act would bring positive relief to consumer prices as a companion to reduced taxes.

- March 2023-July 2023-CIFFA mounted pressure on the federal government during the West Coast ILWU-BCMEA labour negotiations/strike vote.
- October 2023-We published an Executive Director's blog raising awareness about the threat of a labour stoppage at the Port of Montreal if contract not resolved.
- We are participants in the Transport Canada Advisory Group on Aviation Security.
- We are pushing for harmonization between CBSA and Transport Canada on the Pre-load Air Cargo Targeting (PACT) pilot.
- In December 2023 CIFFA presented before the House of Commons' Standing Committee on International Trade's study "The 2023 Strike at the Port of Vancouver: Selected Impacts, Responses and Port-related Innovation".
- January 2024: We put together a submission to the Treasury Board Supply Chain Regulatory Review on: Duplication of Reporting Requirements (i.e. PACT/Transport Canada/CBSA), and the Weakness of Canadian Competition legislation.
- January 2024: We held a Marine Carrier / Freight Forwarder Meeting on eHBL Submission. Discussion regarding inconsistent provision by marine carriers of the consolidated indictor for in-transit cargo to the origin rail carrier.
- E-Manifest compliance: CIFFA is pushing CBSA on its issuance of penalties of almost \$3.3 million.
- February 2024: We participated in an update call with Transport Canada's Pre-Load Air Cargo Targeting program (PACT) team on processes to date, discussion of forwarder concerns regarding the process.
- We are members of the Chamber of Commerce of Canada, which allows us a seat at the table as part of several committees and in front of federal Ministers.
- We have committed to conducting town hall meetings across Canada, informing members what we are up to, and also to draw the interest of prospective members to join the association.
- CIFFA continues to be very involved with FIATA in representing our membership internationally, where we participate on various committees and provide valuable input from a Canadian perspective on initiatives that impact the logistics community across the globe.

On the communications side, our members benefit from expert guidance on inquiries, breaking industry news delivered daily through our invaluable eBulletin, access to The Forwarder online and print magazine distributed twice per year, as well as press releases and Special eBulletins on urgent news.

The Education pillar has formed the cornerstone of CIFFA since the association's inception, and has evolved continuously year-over-year with enhanced, improved and expanded offerings. This is in line with our core belief that education is a journey and not a one-time event.

Our TraversEd Limited, a wholly-owned for-profit entity whose sole focus is to deliver quality education products for the logistics industry, will continue to deliver timely, key, quality training to colleges across Canada, in addition to international educational institutions and other trade associations. These programs have been updated and content localized, with on-demand and virtual offerings to support remote learning.

CIFFA will gradually facilitate the shift towards competency-based dangerous goods training, to provide a workforce skilled for the safe and efficient transport of dangerous goods by air.

Competency based training (CBT) is geared to more than learning how a task is performed, it requires evaluation that the task can be completed with 100% effectiveness in the real world. This will be achieved through virtual class instruction, or asynchronous online lessons, and onsite observations by qualified evaluators.

Furthermore, CIFFA Cares, our registered charity, makes donations (5% of revenue) back to the College Charities. This is a win-win scenario.

We have donated \$100,000 for each of the past two years. This year, we anticipate approximately \$85,000 going back to the Colleges, assisting students in pursuing their education through scholarships and grants.

You, as members, have an important role to play in providing your input towards these goals. Letting us know of your daily challenges, participating in various CIFFA committees and providing an interchange of ideas, input and collaboration will all contribute to our results-driven process.

At CIFFA, communication is always key. Do not hesitate to reach out to us at the Secretariat office with any questions, concerns, and input on how we can assist you.

While the rest of 2024 will undoubtably have more unexpected challenges for the global supply chain, we are a resilient industry, and working together we will find success no matter the situation. Rest assured, your association is ready to assist and to partner with you for whatever comes next. We thank you for your valued support and for being a key part of the CIFFA community.

Treasurer's Report – P. Courtney

Good morning, Ladies and Gentlemen,

It is my pleasure to present my Treasurer's report.

The accounting firm of RSM, has audited CIFFA's financial statements for fiscal year ending December 31, 2023. They have provided the Secretariat and the Board with guidance on accounting practices for "not-for-profit" organizations and we thank them for their professional assistance.

The final draft of the 2023 financial statements has been duly circulated to those who registered for the AGM and approved by your Board of Directors. The full minutes of this AGM will be posted on the Members Only section of our website by early May. Should you also wish a copy of the audited financial statements, please email admin@ciffa.com.

As your Treasurer, I am pleased to share with you this strong financial position, resulting in a solid member surplus.

2023 Revenues – \$1,533,824 2023 Expenditures – \$1,864,572 2023 Equity from Subsidiary - \$845,338

Fund surplus - \$3,068,237

Our revenues increased slightly this past year, 5.7%, primarily a result of the gain in our investment portfolio. Expenses also increased a similar 6.0%. One of the major increases was in our legal expenses, as the board elected to raise awareness to the Competition Bureau on matters of billing practices and demurrage and detention. Another expense was in our member engagement meetings, as several townhall events were arranged throughout the country. Lastly, our for-profit entity improved its net income position by a further 10.1%. Overall, this places the association in a favourable position, improving the fund surplus by 20.2% compared to prior year.

Our revenue is broadly based, with a good mix from, membership, education and Regional events. Our Education portfolio contributes approximately 41.2% of our total revenue, the majority of which comes from our excellent Certificate Courses.

We have invested 19.9% of the member fund surplus in Equity Funds, 3.5% in Fixed Income, while the remainder is invested in various guaranteed investment certificates and short-term deposit notes with major financial institutions.

This concludes my report.

TraversEd Limited - T. Cowen

Dear CIFFA Members, this is my TraversEd Report for the CIFFA AGM April 24, 2024

This past year was focused on increasing our brand awareness with a further concentration on business development. As we are still a relatively new business, with our website launched in early 2023, TraversEd is not a mainstream brand that can rely on mass awareness to drive interest and sales. Rather, we have an emerging brand that requires consistent, targeted outreach to drive traffic to the website and encourage interactions, Our goal was, and will continue, to become synonymous with the industry, global trade education, from an online perspective.

We also developed a business development plan, with a focus on leveraging existing businesses, as well as targeting schools that offer logistics programs, logistics businesses, as well as other trade associations and networks.

Domestically, we continue to partner with Colleges across Canada who benefit from the CIFFA brand and connection to its members. We encourage CIFFA members who are looking to hire new employees to consider hiring from one of our partner schools where many students graduate with an existing CIFFA Certificate.

The course material being offered by TraversEd is the same courses as offered by CIFFA but have been redesigned for an international audience. We are looking to grow both domestically as well as internationally.

College revenue continued to grow in 2023 as existing relationships were expanded, and new partnerships added.

- TraversEd revenues for 2023 grew 24.5% from the previous year to \$2,169,514 with operating expenses increasing only 15.7% to \$1,003,002.
 - Most of the increase in expenses were due to payroll allocation changes and income tax provisions.
 - TraversEd also made a \$100,000 donation to our charity, CIFFA Cares. This
 money is used to give back to the colleges, assisting in loans, grants and
 scholarships for deserving students.

Looking Forward to 2024

On April 1st, 2024, we successfully launched a strategic partnership with the National Customs Brokers and Forwarders Association of America (NCBFAA), where the FIATA diploma will be offered to their members. This program is directly managed and hosted through TraversEd.

On the downside, Canadian Public Colleges were informed of changes to the international student programs, effective this year. Federally, the cost-of-living financial requirement for study

permit applicants was raised to \$20,635. Additionally, Canada imposed a national cap on the intake of international students, with an intention to reduce the intake by 35% over the next two years. Many of our college partners rely on the foreign student population and this could have a negative impact on our results.

In Conclusion

The success of TraversEd equals success and financial security for CIFFA. I am especially thankful for the support that the CIFFA and TraversEd Board of Directors have provided in guiding and supporting the success of this new brand.

Dear Fellow CIFFA Members,

As chair, I am please to provide a recap of your airfreight committee's activities and the variety of issues we have addressed since our last AGM.

There continue to be many challenges in the air cargo supply chain, so if you do not see an issue that concerns you listed below, please alert the committee through the CIFFA secretariat, and we will endeavour to follow-up.

Transport Canada

Pre-load Air Cargo Targeting Program (PACT)

Last month Transport Canada informed CIFFA that they are targeting November 2024 to launch the pre-load data filing. As TC has regulatory control over air carriers, it will be the airlines responsibility to ensure pre-load data filing is transmitted within the prescribed time frame. Direct filing by forwarders will be allowed only if the air carrier authorizes the forwarder to file directly for cargo transported under their air waybill.

CIFFA continues to push CBSA and Transport Canada to align the eManifest Advance Cargo and the PLACT filing, to avoid duplication, increased compliance costs and general supply chain confusion. TC appears to be responsive, but CBSA is less so, as they remain focused on next months CARM implementation.

Dangerous Goods By Air Training

All members are reminded that they must stay compliant with Transport Canada dangerous goods training requirements. While details can be found at https://tc.canada.ca/en/dangerous-goods/training, the requirements for air transport are transitioning to Competency Based Training (CBT) as prescribed by the International Civil Aviation Organization (ICAO). However, the adoption by Transport Canada and the introduction of new regulations is still moving through the approval process in Ottawa. Until Transport Canada officially updates their regulations and sets dates for the implementation of CBT, the current training programs remain valid and recognized by CIFFA and the International Air Transport Association (IATA).

Canada Border Services Agency

eManifest compliance

CIFFA continues to monitor the level of non-compliance penalties assessed, expressing our concern that at level 2 and 3 the amounts are punitive. We reached out to various forwarding associations to learn how their country's regulators enforce pre-arrival data submission compliance. Compared to other countries, Canada tends to be more aggressive in enforcement and its penalty levels higher than the norm.

CIFFA's March 1st bulletin informed membership of a CBSA Communique sent to Foreign Freight Forwarders who have eManifest filing privileges. This notice contained a reminder of their filing obligations. While it is not known what prompted CBSA to issue this communique we do have concerns that CBSA may be considering enhanced compliance action in the near future.

CARM Implementation

In the past few months there have been various industry associations and alliances expressing concerns as to readiness of CBSA to implement CARM and how it may impact on flow of imported goods. Issues such as potential supply chain delays and CBSA IT system instability during the CARM implementation period have been raised, and as speed and efficiency are the

priorities of the air freight, any disruptions can seriously impact cargo operations. Members will find more details on the CARM implementation included in the reports of both CIFFA's Customs and Regulatory committees.

The International Air Transport Association (IATA)

Canadian Air Cargo Program Joint Council

The Joint Council is an IATA body to support consultation between accredited forwarders and air carriers. Should any CIFFA members have a problem with IATA rules, or the Cargo Accounts Settlement System (CASS) please consider bringing your concerns to CIFFA's attention.

At the January 2024 JC meeting CIFFA with the support of the air carriers, was able to have IATA rescinded a proposal to institute an annual fee for intermediary branches in Canada. Avoiding additional costs to Canada's forwarders of between \$ 15,000 – 20,000 annually. Currently the Joint Council has set up working groups to look at the CASS Associates program in Canada, minimum standards for training and staffing requirements, as well as the review of the current IATA Cargo Intermediary Agreement.

CASS Canada

2023 CASS Settlement and Unrecovered Statistics

CIFFA continues to dialogue with IATA, seeking to ensure that our airline partners recognize the historically low credit risk of Canada's forwarding community. CIFFA advocates for fair and reasonable CASS criteria, so as not to place an unnecessary financial burden on CIFFA members.

There were just 12 intermediaries' defaults (not remitting on time or in full) registered between (1 October 2022 – 30 September 2023), further details are as follows, with previous years for comparison.

The collection rate for 2023 was 99.999% vs 2022 which was 99.9992%

Total CASS settlements in 2023 showed a decrease of 15.6% year over year.

Other Items of Note

Digital Cargo Community System

During the past year the committee considered the value Digital Cargo Community Systems (DCCS) might bring to Canada's airports. Such systems have brought significant benefit to cargo operations at airports around the world, especially those experiencing warehouse bottlenecks and significant congestion. The committee with the assistance of our 'airport members' reviewed proposals offered by DCCS consultants, and outcomes of stakeholder focus

groups.

While BCO and ground handlers felt a DCCS could bring further advantages, they and air carriers remained unsure that any gains would offset the costs involved. Additionally, the federal government has not been supportive of regulations and programs to improve supply chain efficiencies, so it appears that until more stakeholders are on board, the DCCS model in Canada is not yet viable.

CUSTOMS COMMITTEE REPORT

Dear fellow CIFFA members,

It has been my pleasure to serve as your Chair of this Customs committee and my pleasure to report on our activities over the past year. As always there are plenty of developments over the year that intersect with our mandate. Even so, the issues that we feel are most important require a whole lot of time and effort by the CIFFA staff and our committee members. It often involves hours in working group sessions on top of all the other activities to advocate for what is right for our members.

The following is an outline of the main developments and CBSA initiatives we worked on in the last year.

New Committee

Part of the CIFFA's strategic plan and to better represent the supply chain, CIFFA has formed another Customs committee – The Customs Regulatory Committee, chaired by Kim Campbell – in the interest of our Customs brokerage members it will focus on customs brokerage and importer issues. Issues covered by this committee might include CARM, Value for duty etc, There might appear to be cross over however as an example, this committee will discuss and advocate on CARM from an importer and Customs broker perspective whereas our committee is more focused on it's impact on the supply chain. Our committee will continue to focus on Customs rules that directly affect the movement of goods and fluidity at the borders. The respective chairs and committees will stay in touch and have discussions on best approaches depending on the matter at hand.

E-House Bill

E-House Bill or E-manifest continue to be one of our top priorities. We continue to push for changes and hope that once CARM has been implemented CBSA will come back to our priorities on this issue. Having said that, we have had some successes over the past year including:

- Postponement of TCC23-017 'A48 RMD Correction, Removal of Customs Port of release and Sub-location code. This change would have meant the CBSA would no longer accept requests for corrections on form A48 for customs port of release and sub-location code. We argued that this was detrimental to trade, trade data and compliance and there might be other solutions. We convinced CBSA to re-think this issue. A big thanks go out to Bruce Rodgers and the CIFFA team. A big win for CIFFA!
- Input on Flying Trucks CBSA had issued a draft of a CBSA Flying Truck document. This new document will be posted on the CBSA website for training and guidance purposes, with a link provided in the revised D3-3-1 which is currently under review. Once the final version is prepared, we will also provide a communication through our eBulletin. We felt it is a good document and CIFFA and this committee had provided feedback.
- Transport Canada's Pre-load Air Cargo Targeting (PACT) this new program aims to identify and apply mitigation measures to high-risk air cargo shipments before they are transported to Canada and is expected to be implemented in late fall of 2024. I include this under E-manifest because many of the data elements are the same and will often result in

double filings. CIFFA is challenging the government to avoid this duplication. This issue also falls under the CIFFA air freight committee.

_

- New CBSA Working Group A new EHBL working group was formed in September that included representatives from CBSA, railways, shipping conferences and of course CIFFA. CIFFA also continues to meet directly with CBSA on EHBL.
- AMPS CIFFA continues to advocate to CBSA for leniency when it comes to eHBL infractions.

The CARM (CBSA Assessment and Revenue Management) Working Group

Bruce Rodgers, your Executive Director represents CIFFA on this working group. As many are now aware, this program will have a profound effect on how imports are handled. This requires importers to register on an on-line CBSA portal and delegate to their Customs broker(s) and other trade chain partners. It will also require importers to post financial security if they want their goods released prior to payment.

During the year we mostly focused on CARM as it relates to the potential impact on our supply chains. At the time of writing this report, we are 9 days away from the cut-over date of April 26th. As of April 26th, shipments will continue to clear Customs however brokers and importers will not be able to confirm the entries until after May 13th nor will importers be able to register for CARM during this period. There are still a significant number of importers that are not registered and few Customs brokerage software providers that are ready (not for lack of trying). There are still many outstanding issues (too many to list in this report) and yet CBSA continues to push forward. There were many concerns expressed by our committee (and industry as a whole) concerning new importers, occasional importers and urgent DDP shipments. After considerable pressure from industry, CBSA came up with some 'solutions' to deal with these situations during the cut over period and beyond but many of them involve using the Customs broker business number. Despite CBSA assurances of waiving liability, we believe brokers will be hesitant to use their numbers and consequently there will be shipment delays. It is our opinion that there will be negative impacts on supply chains starting April 26th and of course your committee will be watching closely. Having said this, at the time of writing this report the Government Standing Committee on International Trade will be recommending that the House of Commons ask the government to suspend the implementation of CARM until they can complete its study and table a final report containing its observations and recommendations. We are eagerly waiting for this recommendation to be tabled and for what the government will do. In the meantime, we all continue to plan for the cut-over period on April 26th and the full implementation on May 13th.

Forced Labour / Trusting Trader Working Group

Canada's new Act on fighting forced and child labour (S-211) came into effect on January 1st. Affected businesses must report on specific details and steps taken in its previous financial year to help prevent and reduce forced labour. These reports are due by May 31st. This requirement may affect many of our members' clients directly or indirectly. There still is conflicting information if some Freight forwarders, Customs brokers and other service providers may need to report. CIFFA produced and presented a webinar during this past year.

Updated Minimum Security Requirements (MSRs) for Freight Forwarders and Customs Brokers under the Partner for Protection program were scheduled to be ready in March 2024 however this has been postponed until sometime after CARM full implementation. CIFFA did provide feedback to CBSA on the proposed MSRs for Freight Forwarders.

Your Customs committee

Our committee meets 5 or 6 times a year by video conference. We have a very strong committee that has a good grasp of the technical issues and bring a range of small, medium, and large company perspectives. I would like to thank our committee members for their volunteer time and their companies for allocating their resources.

I would also like to thank the CIFFA secretariat and my fellow board members for their support through the year. And a special thank you to Bruce Rodgers, Julia Kuzeljevich and Kim Biggar at CIFFA for all their time, effort, and expertise.

Drayage Committee Report

Dear fellow CIFFA Members.

Drayage, an essential service and an integral part of the transportation and shipping process, ensuring that cargo reaches its final destination efficiently. It is the transport of goods over a short distance in the shipping and logistics industries.

Drayage is often part of a longer overall move, transporting goods from or delivery to a seaport, border point, inland port, intermodal terminal or warehouse with both the trip origin and destination in the same urban area. It is an important component and contributor especially in cold logistics and the container industry and fills the gaps in intermodal shipping. It may involve shifting the cargo from one mode of transport to another. Cargo transport all over the world requires millions of drayage movements every year.

The mandate of the CIFFA Drayage Committee is to represent and protect the interests of members, while also consulting and informing on issues of concern both regulatory and operationally.

Below are some highlights of what the Drayage Committee has been working on.

CN and CPKC Meetings

We have held a number of meetings with CN over the past year, which allowed us to inform members of operational changes within CN's network. We are pleased to report that CN's service has improved, in part due to the close collaboration we've had with them. CP's acquisition of Kansas City Southern on April 14, 2023, created some challenges with scheduling meetings with the newly formed CPKC. We did have a meeting with CPKC on November 28, 2023, where several recommendations were put forth. We continue to work on these initiatives and will be reviewing during an in-person at CP Vaughan.

Drayage Town Hall

We have tentatively scheduled an In-Person Drayage Town Hall in Toronto for June 18, 2024. The purpose of this event is to bring the Drayage Community together to discuss the issues affecting this sector. We will also use this event as a Membership Drive directed at the Drayage Community.

EDUCATION REPORT

CIFFA Members, this is my Education Report for the CIFFA AGM April 24, 2024

I am pleased to report that 2023 was another successful year for CIFFA Education.

Highlights from 2023

CIFFA continued to offer a wide range of online education programs in support of our members learning needs. This includes the CIFFA Certificate and the FIATA Diploma Course – Advanced Freight Services Management courses from the Schulich School of Business, Dangerous Goods courses in air, sea and land, Air Cargo Security, and various industry workshops.

In 2023, CIFFA education revenues were **\$610,787** which is a slight increase over 2022. Operating expenses for the education programs came in at **\$205,953**.

Some notable results for enrollment in 2023 include:

- Enrolment in all 2023 education programs was comparable to 2022.
- Schulich Management courses in Sales, Client Service and Financial accounting experienced further growth in 2023 and experienced its most successful year since its launch. These courses are the final courses required to achieve the CIFFA PFF designation.
- CIFFA continues to teach its established virtual workshops and offers 14 courses, including the launch of Force Labour, Force Majeure, Sustainability, and a soft skill course called Grad Force.

This financial success of CIFFA's educational offerings allows for investment in new training development and technologies. CIFFA will continue to create new course offerings, improving existing content, and promoting the CIFFA Professional Freight Forwarder (PFF) Designation.

I am very appreciative of the continued support of our members in 2023. Being a not-for-profit association, we heavily depend on Member support to fill our programs with participants and because of that support, the CIFFA Education team is able to revise and update current programs, while developing new program offerings.

Looking Forward to 2024

In 2024, CIFFA will focus on updating and re-designing course material as needed. Including:

Certificate program improvements:

- CIFFA will continue to work towards updating the delivery of the online certificate
 courses this year. This includes the revalidation of its course material with FIATA. The
 FIATA minimum standards have also been updated, so additions to the course material
 will occur throughout the year.
- All course content is continually evaluated through learner feedback and updated based on this feedback and any industry changes.

Workshops:

CIFFA is working with its members to create new workshops that are timely and relevant. A few new workshops are expected to launch in 2024.

FIATA REPORT

Dear fellow CIFFA members,

Please find below my AGM report.

I was elected to the FIATA Presidency for the 2023-25 term. I would like to thank CIFFA for their continuous support. I have attended two Presidency meetings to date (one in- person and one virtual), the first being in Sao Paolo. I was well received.

The new President and Presidency are determined to make positive change, increase communication with members and get the Extended Board and Institutes working together on special projects, membership engagement and increasing the value to members.

I was appointed rapporteur for the Airfreight Institute (AFI) and Advisory Body on Safety and Security (ABSS). I am excited about the appointment and responsibilities on both institutes where my main function is liaison between AFI /ABSS and the Presidency. I look forward to being involved and contributing to some of the great initiatives we have started and continue to develop.

The IATA-FIATA Consultative Council (IFCC) has had a busy year with the Presidency, the IFCC governing body and developments with headquarters. We presented IATA with a draft Global Air Cargo Program for their review. It is currently being studied and the governing bodies are discussing and deliberating what is acceptable, requires change or will not be approved. At the Cargo Advisory Council (CAC) meeting in Hong Kong last March, FIATA Director General, Stephane Graber, and FIATA Legal Services Director, Andrea Tang, presented the draft submission and benefits of a global program to IATA and their membership.

On a positive note, IATA and the CAC Chairperson, Stefan Amann, agreed to create a working group agreed to create a working group with FIATA and IATA to tackle the Global Air Cargo Program. Brendan Sullivan, IATA's Global Head of Cargo, also went public with a positive comment, emphasizing that industry must work together in these challenging times and everchanging marketplace. At the upcoming FIATA headquarter meetings in Geneva, Willy Walsh, IATA Director General, will be the guest speaker at the opening session and "exclusive fireside chat" where we will further promote the benefits of the Global Air Cargo Program, required timelines and project plan to complete a successful program.

Dangerous Goods joint initiatives on industry safety; we are still awaiting IATA for the joint working committee, times and participants within approximately18 months and there has been

no further developments from IATA to comment on.

Working Group Sea continues advancing on our great initiatives including past ones that remain relevant, demurrage and detention, carrier relations and negotiations as well as schedule integrity. We are focusing on the changes in the alliances. MSC, taking on the world alone, Maersk and Hapag under the new Gemini alliance. The Ocean Alliance remains intact. The Alliance will reinvent itself with the current changes.

I am heading to Geneva for the 2nd meeting of the Presidency and I will have more to report upon my return.

Freight Broker Committee Report

Dear fellow CIFFA members:

As chair, I am please to provide a recap of your Freight Broker committee's activities over the past year and some of the initiatives that have been raised.

Double Brokering

- This is a big and growing problem in the industry.
- There are two types of double brokering models:
 - Those that do it as a business model, by reselling loads to gain a small percentage. This practice is not illegal in Canada. In the U.S., double brokering must be disclosed.
 - o Those who do it illegally: Sometimes they steal the load, but normally they do it to make money, with no intention of paying the second broker.
- As a result of these serious challenges, CIFFA prepared a whitepaper on Double Brokering, which can be located in the Resource section of the website.
- The Freight Broker committee held their first ever in person event on May 29th in Mississauga, with 45 attendees.
- Presentations were made from Gardiner Roberts LLP (who developed the white paper) and Roanoke Insurance

CARB - In 2024 the California Air Resources Board (CARB) ruling came into effect.

- Freight brokers and forwarders can assign California routes (to, from or through) only to CARB (California Air Resources Board) compliant carriers. They must ask for proof of compliance.
- New reporting requirements are in place as of the new year, related to the following: the Transport Refrigeration Unit (TRU) Regulation, the Clean Truck Check (CTC) Program and the Advanced Clean Fleets (ACF) Rule.
- CARB attestations must be renewed annually.

Carrier Vetting Systems

• With the rise of double brokering and carrier scams the committee looked at various carrier vetting systems including Carrier Assure, Highway and Freight Validate.

FMCSA Broker Financial Backing

- Any broker (or forwarder) moving freight to, from or within the U.S. must post a \$75,000 surety bond. A carrier that is not paid by a broker can seek payment from the surety holder and, if approved, receive funds from the bond.
- The FMCSA is now saying that, in such cases, brokers must add funds to the bond to return to \$75,000 within seven days and the committee supports this proposed change.

Insurance Update

- Nuclear verdicts in the U.S. have included freight brokers, despite the fact they don't
 move freight. However, in at least a couple of recent cases, U.S. courts denied broker
 responsibility in truck accidents, which is good news from the insurance perspective,
 because some companies were stepping back from offering coverage.
- Coverage for such risk is offered as "hired auto" in Canada, "contingent auto" in the U.S.

- Double brokering is still a massive issue in the insurance industry. More policy
 restrictions are being put in place, saying that there will be no coverage if the trucking
 company that picks up the freight is not the trucking company hired by the broker.
 Brokers could be held liable for losses.
- Insurance companies are being more specific about carrier vetting procedures. E.g., is the broker using a third-party company to monitor carriers?
- Insurers want to see a distinct separation between the asset and non-asset-based sides of a company, to the extent that the two sides should have different names, separate websites.
- Freight brokers are increasingly offering all-risk cargo insurance to clients, rather than
 relying on carrier coverage for losses. Offering such insurance can help brokers expedite
 the claims process and retain customers. Most insurance providers offer real-time
 quotations.
- The U.S. Federal Motor Carrier Safety Administration (FMCSA) recently published its final rule for freight broker/forwarder financial liability. It describes acceptable asset types for the \$75,000 financial security. There are rumours that the FMCSA is looking at increasing the amount of the financial security.
- The FMCSA has initiated a rulemaking, Transparency in Property Carrier Broker Transactions, after trucker protests that freight brokers were overcharging. On demand from truckers, brokers will have to disclose within 48 hours what they charged for a shipment and who the shipper was.

Ontario Ministry of Transportation Permitting

- Obtaining permits from the MTO is inconsistent and delayed, at times taking up to 15 days.
- Members feel that 48 to 72 hours is a reasonable time frame to get a permit, noting that in Michigan, permits are issued in less than 24 hours.
- The MTO website says that a single-trip permit is issued within three days.

The committee focus for 2024 will include:

- Best practices workshop or document to help Freight Brokers vet and set up carriers to avoid being the victim of a scam.
- Develop a broker-shipper contract
- Partner with Loadlink, or one of the online carrier vetting systems.





Regular member retention rate is high and stable (97.0% this year, which is consistent with the year prior)

SEA FREIGHT COMMITTEE REPORT

Dear Fellow Members.

The national sea freight committee met on four occasions since the last AGM, as well as multiple committee members were involved in several other discussions with multiple supply chain stakeholders. The year 2023 was very challenging, with several obstacles such as labor disruptions and congestion. Starting 2024, these issues in different forms may still be present, but I assure you that CIFFA is very well positioned to help guide a path forwards. Please let me discuss two of the current challenges facing our industry and how CIFFA has positioned themselves.

Labor Disruptions

In 2023, we dealt with labour disruptions in the Port of Vancouver and also the St. Lawrence Seaway. Thank fully these are both now resolved, but currently the union representing the ILWU and the Maritime Employer Association do not have an agreement in place. Later in May, after a federally assisted mediation process, both CN and CP face a potential disruption with the TCRC

Congestion

Even with softer volumes, there are high levels of containers on the ground at the Port of Vancouver. Some efforts were made to relieve this, but those efforts just contributed to congestion at inland terminals.

Collaboration

Building on the work of the various committees, regular dialog has been established with major stakeholders such as: The Supply Chain Office of Transport Canada, The Shipping Federation, The Chamber of Shipping, CBSA, both railways, ports, various organizations such as CITT, and CIFFA also employs a lobbyist in Ottawa.

Problem Resolving

We must also learn from past challenges in order to be better positioned to overcome future obstacles. A serious issue that our industry recently faced was empty returns, and associated detention and demurrage fees. Although this is not a regular occurrence today, steps have been taken so if those challenges arise, a faster response and resolution should be available. With the level of engagement mentioned above, CIFFA and the sea freight committee hope to proactively deal with issues like inland terminal congestion, added volumes, and regulatory changes if they arise.

I would like to take a moment to recognize and thank all the committee members and their employers for their support and dedication to the Ocean committee.

Sustainability Committee Report

Dear CIFFA Members,

I'm pleased to share the following Sustainability Committee report for CIFFA's 2024 AGM.

January 2024 marks three years since the Sustainability Committee was formed. Our first Blueprint document, an Introductory Guide to Sustainability for CIFFA Members was released June 27, 2023. This is an introductory guide, that considers all regular membership categories, outlining key sustainability goals and principles, includes examples of vendor checklists, a glossary, resources, and actions steps to take starting from within an organization. It includes a detailed focus on environmental perspectives, GHGs and the impact of transport.

The second e-book is currently under review, to outline key sustainability goals and principles for CIFFA members. The series will follow in the theme of ESG and three key pillars of environment, social and economic.

Competent Boards Assessment Tool

In partnership with Copenhagen Business School (CBS), Competent Boards have developed an assessment tool that measures board sustainability competencies. The tool methodology considers certain factors with board member roles, experience, and education. A new report that applies the tool, provides analysis in assessing board competency scores in Europe and US, public companies in the Fortune 500 for the year 2023. It "reveals a concerning reality: a significant number of boards lack basic sustainability expertise"

In another article about The Changing Face of Boardroom Competencies, it states: "The contours of effective leadership are expanding. While traditional skills remain valuable, there's a broadening need for knowledge of ESG, sustainability, digital technology and forward-thinking, values-driven leadership. Today's ideal board member must be curious, understand the needs of modern businesses, and able to make balanced risk decisions."

Pledge

CIFFA signed a Memorandum of Understanding in November 2023, with Pledge Earth Technologies Ltd., a carbon emissions measurement and offsetting platform. This new partnership will provide research documents for member benefit, as well as offering informational webinars to educate members.

Pledge provides software solutions to empower logistics service providers to support their clients in meeting their sustainability goals. Pledge provides a new level of accessibility and transparency to freight emissions measurement, reporting and offsetting, allowing businesses to offer these services without increasing operational costs.

UN Global Compact Network Canada (GCNC)

CIFFA has been a Participant of the UN Global Compact since September 2021. On August 18th, 2023, CIFFA filed a required Communication on Engagement (COE) report, which highlighted specific activities undertaken in the areas of human rights, labour, environment and anti-corruption. A copy of the report is posted in the Resource section of the website. The following is a summary of CIFFA's efforts and engagement in sustainability initiatives and education, in support of members:

- By actively building and participating with global networks
 - Member of UN Global Compact to support CIFFA's direction and accountability measures
 - Associate member of the SmartWay
 - Associate member of Smart Freight Centre
 - Associate member of the Global Logistics Emissions Council
- By developing CIFFA Sustainability course, and sourcing other industry-specific options
- By communicating related sustainability news, such as latest in logistics technology to reduce carbon emissions (for example, real-time tracking and predictive analytics to optimize routes and reduce fuel consumption)
- By advocating for international freight forwarding and global logistics industry
- By keeping an evergreen glossary of terms and concepts
- By providing guidance and helpful resources to members
- By making available tools and resources created by FIATA (International Federation of Freight Forwarders Association) and, where beneficial, adapting for a Canadian context:
 - The FIATA Carbon Calculator
 - The FIATA Advisory Body on Safety & Security
 - The FIATA Sustainability Working Group
 - The FIATA Environmental Declaration
 - o The FIATA Young International Freight Forwarder of the Year Award.

Global Compact Network Canada (GCNC) is focused on the environment theme in 2023, developing a Climate Accelerator, and also hosted webinars on: Transformational governance, Decent work and training workshop, and Sustainable finance

World Transport Day

November 26, 2023, was designated "World Sustainable Transport Day" by a special UN General Assembly Resolution. The UN Group of Friends for Sustainable Transport (GFST) invited all Member States, organizations of the United Nations system, international and regional organizations, and civil society, including non-government organizations, individuals, and other relevant stakeholders to mark the World Sustainable Transport Day by means of education and holding events aimed at enhancing the knowledge of the public on sustainable transport and global supply chain issues.

CIFFA Members, this is my TraversEd Report for the CIFFA AGM April 24, 2024

TraversEd is wholly owned by CIFFA, and is responsible for domestic and international strategic partnerships, including College relationships, association education partnerships, and students outside of Canada.

The course material offered by TraversEd are the same courses as offered by CIFFA, but have been redesigned for an international audience, and are branded as TraversEd.

Some notable highlights for 2023 include:

- TraversEd became a member of the AACSB which is an association of international business schools. This will offer more exposure for the new brand to an international audience.
- TraversEd and the National Customs Brokers and Forwarders Association of America (NCBFAA) entered into an agreement where TraversEd would provide courses to NCBFAA members, and grant TraversEd the rights to validate and offer the FIATA diploma in the United States.

Partner Growth - TraversEd continues to partner with Colleges across Canada who benefit from the CIFFA brand and connection to its members, as they offer the CIFFA certificate and FIATA Diploma courses to their students. College revenue continued to grow in 2023 as partnerships were expanded, and new partnerships added.

 TraversEd revenues for 2023 grew 24.5% from the previous year to \$2,169,514 with operating expenses increasing 15.7% from 2021 to \$1,003,002

This financial success allows TraversEd to invest in new training development and technologies.

Looking Forward to 2024

In 2024, TraversEd will validate its course material with FIATA, for the right to offer the FIATA Diploma in the United States.

TraversEd / CIFFA enjoys educational partnerships with 15 Colleges in Canada who offer Supply Chain and International Business programs. We encourage CIFFA members who are looking to hire new employees to consider hiring from one of our partner schools where many students graduate with an existing CIFFA Certificate.

There is a risk of lower student enrolment in Canadian Colleges in 2024. The federal and provincial government have implemented restrictions to the number of international students allowed to study in Canada. This will have a significant impact on the Fall enrolment of students in 2024, and into 2025.

TraversEd will continue to look for new opportunities outside of Canada, especially with international colleges and universities, and national associations.

Conclusion

The success of TraversEd equals success and financial security for CIFFA. I am especially thankful for the support that the CIFFA and TraversEd Board of Directors have provided in guiding and supporting the success of this new brand.
